Before Installation

- Please familiarize yourself with the contents of these Release Notes for details regarding this version of MicroBiz.
- You must be on MicroBiz Business/Liquor/Bike Controller series for Windows version 9.0 or above to apply this update.
- As with any upgrade or change to your MicroBiz system, a complete backup of your Local and System Files Paths (BizWin and Business directories by default) should be made prior to the upgrade.

Highlights

MicroBiz v15.5 was released to comply with EMV Standards. EMV or Europay MasterCard Visa was implemented into the MicroBiz environment due to a liability shift to take effect 10/01/2015. This update was also designed to fix some of the ongoing flaws that became introduced when version 15 of MicroBiz was released. Please view the list below for more information on fixes and enhancements added to v15.5. Bold items have been released in v15.5.2.

Fixes

This section lists all Issues that have been fixed as of this release.

- Sporadic Closeout Errors causing closeouts to fail or not print or carry previous data
- Print Credit/Debit Card Receipt / Print Additional Credit/Debit Card Receipt is fixed
- DOS or Impact Style Printing Improved with DOS Control Codes
- Resource File error after installation fixed
- Department/Style/Size/Color - Duplicate Code ID error fixed
- Department/Style/Size/Color – Close button is fixed
- DB_Bufflock errors are fixed
- Alternate Payment Types now show at EOD
- Duplicate Vendor ID error fixed
- Vendor Setting for Average Lead Time on all PO's is fixed
- **Notes are easier to read / not displaying in reverse**
- **CC Expiration Date now prints as xx/xx**
- **Print Digital Signature/Notice is only available when a sig cap device is enabled**

Features

This section lists all other Improvements to the version 15.5 of MicroBiz.

- OpenEdge EMV Compatibility with X-Charge or OpenEdge v8.1.1 or Better
- Print 80-Column Receipts through your PDF Program. v15.5 introduces passthrough compatibility for 8.5x11 sheet style printers that would not print in MicroBiz before.
(**Print Setting**)
- New Disallow Charge to Account setting located in each Customer's Account Record
- OpenEdge Receipts have been updated to print the Credit Card Name or the Customer loaded based on returned data from OpenEdge
- Receipts have been updated to print digital signatures when captured* and the print setting to print digital signatures is checked (where applicable).
*This Signature does not print for Gift Cards or Payment Types other than Credit Card
- Receipts have been updated to print the notice of a digital signature captured if the print setting to print Notice of Digital Signatures is checked
- We now have the MicroBiz Show My PC application added to the installation and can now be launched by going to the Main Menu and selecting Help.
- **Ship Via Print Settings works with Invoice 18**
- **Condensed EMV Receipts are present**
*at least one condensed receipt per invoice format 80 or 40 column, per vertical
- **Slow/Fast Moving Products (Addition of Fast Moving Product Filter)**
